INTERNATIONAL MULTIPLE UNIT FRANCHISE AND DEVELOPMENT AGREEMENT WITH CAJUN GLOBAL LLC FOR "TEXAS CHICKEN" RESTAURANTS IN INDONESIA

The board of directors (the "Board" or the "Directors") of Envictus International Holdings Limited (the "Company" and together with its subsidiaries, the "Group") wishes to announce that on 12 June 2018, the Company's indirect wholly-owned subsidiary, PT. Quick Service Restaurant, has entered into an international multiple unit franchise and development agreement ("IMUFDA") with US-based franchisor, Cajun Global LLC, to develop 80 franchised "Texas Chicken" exclusively for the territories of parts of West Java, Jakarta, Banten, Lampung, South Sumatra and Bengkulu in the country of Republic of Indonesia for 10 years from 2018 to 2027.

The *Texas Chicken* restaurants serve American-styled, big juicy full-flavoured fried chicken, crunchy juicy tenders, burgers and wraps, french fries, mashed potatoes, coleslaw, honey-butter biscuits, ice-cream shortcakes and sundae, to name a few.

This business expansion is part of the Group's growth strategy to increase the presence of Envictus Group's identity in key markets of the neighbouring country in Asia. In Malaysia, the Group's whollyowned subsidiary, Texas Chicken (Malaysia) Sdn Bhd, which is an existing franchisee of Texas Chicken for Malaysia and Brunei, has since its inception in 2013 successfully opened 47 restaurants in Peninsular Malaysia mainly in well-populated areas with high traffic volume, as well as tourism hotspots.

This new business expansion into Indonesia will enable the Group to leverage on the business networks and connections developed through the Group's past endeavours in Indonesia and to tap on the experience of the existing corporate and operational resources used for its current Texas Chicken restaurants in Malaysia in addition to developing an additional stream of revenue and earnings for the Group.

The entry into the IMUFDA is not expected to have any material impact on the Group's net tangible assets per share or earnings per share for the financial year ending 30 September 2018.

None of the Directors or controlling shareholders of the Company or their respective associates has any direct or indirect interest in the IMUFDA, other than their respective shareholdings in the Company.
